In consideration of the use of Obstacle Course, Paddle Board, Kayak, Bicycle, participation in Soccer Camp, Group Training, or Yoga, I hereby release, waive, and discharge Attitude Sports Training Solutions LLC (“Attitude Sports”), its directors, officers, employees, and agents from liability from any and all claims including negligence of Attitude Sports and my own negligence resulting in personal injury, property damage, wrongful death or other claims that arise from my use of the Obstacle Course, rental of Paddle Board, rental of Kayak, rental of Bicycle, participation in Soccer Camp, Group Training, or Yoga.

I, the undersigned, hereby state that I am in good health and am physically qualified to participate in the exercises and associated physical activity of any and all personal training sessions.

I, _____, understand that use of the Obstacle Courses, Paddle Boards, Kayaks, Bicycles and participation in Soccer Camp, Group Training, and Yoga all carry certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another. I understand that it is my responsibility to assess the hazards presented by my use of said equipment or my participation in said activity and further agree that I am the ultimate decider of whether I can use the equipment or participate in the activity with the risk of harm to myself.

I have read the previous paragraphs and I know, understand, and appreciate the risks that are inherent in the activities or the use of said equipment. I assert that the use of said equipment or participation in said activity is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to indemnify and hold Attitude Sports Harmless from any and all claims, actions, suits, procedures, costs, expenses, and liabilities, including, but not limited to personal injury, property damage, wrongful death, as well as attorney’s fees, as a result of participation in said activity or rental of said equipment and to reimburse Attitude Sports for any such expenses incurred whether caused by negligence, my own negligence or Attitude Sports’ negligence, breach of contract, or otherwise.

Severability: I further expressly agree that the foregoing waiver is intended to be as broad and inclusive as is permitted by the laws of the State of Wisconsin and if any portion thereof is held

invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: I have read this waiver and understand that I am giving up substantial rights including my right to sue. I acknowledge that I am signing this agreement freely and voluntarily, and intend that my signature be a complete and unconditional release of all liability related to my use of the Obstacle Course, rental of Paddle Board, rental of Kayak, rental of Bicycle, my participation in Soccer Camp, Group Training, or Yoga to the greatest extent allowed by law.
